Call to Order

Pastor Robert Franseen called the meeting to order on behalf of Ken Honeck at 8:30 a.m.

Roll Call

John McGovern then called roll. Ken Honeck was excused. All other members of the board were present. Rick Jones was welcomed as newly appointed to the board.

Approve/Amend Agenda Items

The board reviewed the agenda for the May 17, 2023 meeting. Rick Jones moved to approve the agenda. Deb Hermann seconded the motion and the board voted in favor 7-0.

Visitor Introductions

Pastor Robert Franseen welcomed in-person and virtual visitors to the meeting.

Approval of Minutes

Deb Hermann made a motion to approve the minutes from the April 19, 2023 meeting. Nic Riesenberg seconded the motion and the board voted in favor 7-0.

Finance Report

Bruce Culley gave an overview of the financial report for April 2023. Sales tax revenue in April 2023 totaled \$980,758.51, an 14.88% increase compared to April 2022. The total fund balance as of April 30, 2023 was \$15,660,240.61, with \$10,545,631.88 in total grants committed. Revenue in April 2023 totaled \$995,020.59 and expenses totaled \$1,316,891.48, for a total net operating revenue in April 2023 of (\$321,870.89). With a motion by Pastor Robert Franseen and a second by Nic Reisenberg, the board voted to approve the financial report as presented 7-0.

Executive Director's Report

Kathy Macken shared budget revisions recently approved:

- Missouri City School District reallocated \$1,795.60 from the therapy supply line item to professional development.
- Kearney School District reallocated \$113,000 from various line items. New Strong KC charged per student for group therapy, resulting in exceeding the budget line, and termination of their contract.

Next, she presented the new window decal to be used on doors at school buildings, and new logo lanyards. Other items with the CSF logo are available for community-based services partners.

Lastly, Ms. Macken shared that the community-based services applications are ready for review by the Programs Committee. Summaries were provided to all board members.

Action Items

Pastor Robert Franseen presented the Programs Committee's review of the 2022-2024 School-Based Services renewal requests. The funding amount for North Kansas City Schools reflects their program without the mentoring program that is being re-evaluated to be considered. The funding amount for Smithville School District does not include their request for funding for the SRO. Other revisions to the 2023-2024 amounts may be made. Pastor Robert Franseen moved to approve the committee's recommendations listed below, and John McGovern seconded the motion. The board voted in favor 7-0 to award the following school-based services renewals:

The Program Committee will meet June to discuss Community-Based Services applications.

John McGovern noted that the June meeting agenda will include a closed session for the board to discuss personnel issues.
