Call to Order

Roll Call

John McGovern then called roll. All members of the board were present.

Approve/Amend Agenda Items

The board reviewed the agenda for the July 19, 2203 meeting. Deb Hermann moved to approve the agenda. Pastor Robert Franseen seconded the motion and the board voted in favor 8-0.

Visitor Introductions

Ken Honeck welcomed in-person and virtual visitors to the meeting.

Approval of Minutes

Nic Riesenberg made a motion to approve the minutes from the June 21, 2023 meeting. Deb Hermann seconded the motion and the board voted in favor 8-0.

Finance Report

Bruce Culley gave an overview of the financial report for June 2023. Sales tax revenue in June 2023 totaled \$1,007,283.48, a 3.22% decrease compared to June 2022. The total fund balance as of June 30, 2023 was \$14,779,460.54, with \$7,816,730.48 in total grants committed. Revenue in June 2023 totaled \$1,023,438.01 and expenses totaled \$1,289,962.44, for a total net operating revenue in June 2023 of (\$266,524.43). With a motion by Deb Hermann and a second by Pastor Robert Franseen, the board voted to approve the financial report as presented 8-0.

Executive Director's Report

Kathy Macken presented the following approved budget reallocation:

 Northland Therapeutic Riding Center reallocated \$7,500 from the unfilled Program Director position to support new instructor training and unexpected vet bills.

She also shared that a draft of the 2022 CSF Impact Report has been completed.

Lastly, Ms. Macken shared that her cell phone was stolen, and the PayPal account connected to the CSF funds was used. A police report has been filed, and it is in dispute with the bank whether the stolen \$300 will be reimbursed to the fund. The CSF card on the PayPal account has been deactivated and new cards have been ordered.

Action Items

Next, Pastor Robert Franseen presented the Programs Committee's 2023-2024 Community-Based Service award recommendations. Pastor Robert Franseen made a motion to approve the committee's recommendation to award applicants listed below. Deb Hermann seconded the motion and the board voted in favor 8-0.

The staff shared about the Safe and Resilient Children and Resilient Youth programs currently supported by the CSF. Following the presentation, the Synergy Services staff answered questions from the members of the board.
