# Minutes Clay County Children's Service Fund Board Meeting September 20, 2023

# Approve/Amend Agenda Items

The board reviewed the agenda for the September 20, 2023 meeting. Rick Jones moved to approve the agenda. Bruce Culley seconded the motion and the board voted in favor 8-0.

### **Visitor Introductions**

Ken Honeck welcomed in-person and virtual visitors to the meeting. Ken also welcomed new board member, Kelly Kobylski.

# **Approval of Minutes**

Pastor Robert Franseen made a motion to approve the minutes from the August 16, 2023 meeting. Nic Riesenberg seconded the motion and the board voted in favor 8-0.

### **Finance Report**

Bruce Culley gave an overview of the financial report for August 2023. The total fund balance as of August 31, 2023 was \$14,050,164.79 with \$14,219,402.40 in total grants committed. Revenue in August 2023 totaled \$1,104,443.12 and expenses totaled \$1,533,094.95, for a total net operating revenue in August 2023 of (\$428,651.83). Sales tax revenue in August 2023 totaled \$1,080,354.82, a 0.17% increase compared to August 2022. With a motion by Ken Honeck and a second by Nic Riesenberg, the board voted to approve the financial report as presented 8-0.

# **Executive Director's Report**

Kathy Macken presented the following approved budget revisions:

- Smithville School District reallocated \$3,000 from therapy to increase support in the unexpected temporary shelter services budget line.
- Ability KC reallocated \$43,742.60 from Behavioral and Cognitive Interventions to Therapeutic Preschool to support increased enrollment for Clay County children.
- MOCSA reallocated \$6,160 from Program and Therapy Supplies to support the counseling coordinator's therapy work due to position vacancies.

She also shared that Clark Hanner from Marr and Company anticipates having a draft of the 2022 Financial Audit for the Finance Committee by the end of September.

Additionally, CommCARE will conduct service audits again this year. The audits will be completed by a team of 3-4 professionals instead of 1. CommCARE promises quality reports.

Ms. Macken shared that Peggy has been unable to download bank activity to QuickBooks since mid-August. Ms. Macken and Peggy met with employees from Central Bank. Peggy will have a meeting to set up ACH payments and Central Bank will refund the QuickBooks charges. The board shared their appreciation for Central Bank's responsiveness and partnership.

Next, Kathy Macken shared that the 2022 Impact Report is in production and will be made available soon.

Ms. Macken also shared an update regarding her stolen phone and Pay Pal account hack in July. Pay Pal refunded the full amount of \$300.

Lastly, she presented key takeaways from her meeting with other Missouri Children's Services Funds. Clay County Children's Services Fund ranks 3<sup>rd</sup> in sales tax revenue.

### **Kearney School District Presentation**

The board invited Jennifer Kopp and Meeghan Masters from Kearney School District to present on the agency's programs. The staff shared results from programs such as the Portrait of a Graduate Program, Bulldogs C.A.R.E. program, and their social-emotional learning programs, noting their positive impacts within the school district. Following the presentation, the Kearney School District staff answered questions from the members of the board.

#### **Other Business**

The board reviewed their Conflict of Interest policy. The board will return their signed forms to Kathy Macken once completed.

The board also shared their appreciation for Sarah Forgey's work over the last five years and the Greater Kansas City Community Foundation's work as a whole. Beginning in October, Afton Baxter at Greater Kansas City Community Foundation will take over Ms. Forgey's role.
