Call to Order

Roll Call

John McGovern then called the roll. Ken Honeck, Pastor Robert Franseen, and Deb Hermann were excused. All other members of the board were present.

Approve/Amend Agenda Items

The board reviewed the agenda for the October 18, 2023 meeting. Rick Jones moved to approve the agenda. Nic Riesenberg seconded the motion and the board voted in favor 6-0.

Visitor Introductions

Kathy Macken welcomed in-person and virtual visitors to the meeting.

Approval of Minutes

Nic Riesenberg made a motion to approve the minutes from the September 20, 2023 meeting. Kelly Kobylski seconded the motion and the board voted in favor 6-0.

Finance Report

Bruce Culley gave an overview of the financial report for September 2023. The total fund balance as of September 30, 2023 was \$13,674,517.24 with \$21,255,035.78 in total grants committed. Revenue in September 2023 totaled \$1,141,212.85 and expenses totaled \$1,514,926.84 for a total net operating revenue in September 2023 of (\$373,713.99). Sales tax revenue in September 2023 totaled \$1,114,571.90, a 1.18% decrease compared to September 2022. With a motion by Nic Riesenberg and a second by Rick Jones, the board voted to approve the financial report as presented 6-0.

Executive Director's Report

Kathy Macken presented the following approved budget revisions:

- Excelsior Springs School District reallocated \$45,000 for Early Childhood Center Behavior Intervention Services.
- Kearney School District reallocated \$68,910.04, part of which is to assist with their June expenditures of \$37,710.

She also shared that she and Ken Honeck met with PorchLight Insights to kick off strategic planning. A board work session will be held on November 13, 2023.

Additionally, hard copies of the 2022 Impact Report are available in the office and an electronic version is available on the website.

Next, Kathy Macken shared that other Missouri Children's Services Funds are in the process of finding new grant management software. She will provide an update once there is consensus. Ms. Macken also announced some changes to the Greater Kansas City Community Foundation contract.

Next, Ms. Macken shared that Peggy received training from Central Bank for ACH payments to grantees. Ms. Macken and Peggy are reviewing another option for accounting, Bill.com and will report back to the board. The software works with QuickBooks and will help bridge the gap between QuickBooks and Central Bank.

Lastly, Kathy Macken shared that Clark Hanner from Marr and Company has presented a draft of the 2022 Financial Audit to the Finance Committee. The final draft with recommendations will be made available soon.

The board invited Susan Bartlett from North Kansas City School District to present on the district's programs. North Kansas City School District works closely with Beacon Mental Health (formerly Tri-County Mental Health Services) and Synergy Services to provide services such as individual and expressive therapy, resiliency, and behavior support implementation. One of their recent successes has been the implementation of Hope Squad, which is peer-to-peer mentoring for elementary and secondary students. Following the presentation, Ms. Bartlett answered questions from the members of the board.

Other Business

Ms. Macken shared that there are a variety of handouts available for board members and visitors.

The next Board of Directors meeting is to be held on November 15, 2023.
