Minutes Clay County Children's Service Fund Board Meeting December 13, 2023

Call to Order

Ken Honeck called the meeting to order at 8:30 a.m.

Roll Call

John McGovern then called the roll. Pastor Robert Franseen and Deb Hermann were excused. All other members of the board were present.

Approve/Amend Agenda Items

The board reviewed the agenda for the December 13, 2023 meeting. Nic Riesenberg moved to approve the agenda. Bruce Culley seconded the motion and the board voted in favor 7-0.

Visitor Introductions

Ken Honeck welcomed in-person and virtual visitors to the meeting.

Approval of Minutes

John McGovern made a motion to approve the minutes from the November 15, 2023 meeting. Nic Riesenberg seconded the motion and the board voted in favor 7-0.

Finance Report

Bruce Culley gave an overview of the financial report for November 2023. The total fund balance as of November 30, 2023 was \$12,951,237.23 with \$20,550,582.49 in total grants committed. Revenue in November 2023 totaled \$978,415.14 and expenses totaled \$2,453,618.15 for a total net operating revenue in November 2023 of (\$1,475,203.01). Sales tax revenue in November 2023 totaled \$947,453.65, an 11.74% increase compared to November 2022. With a motion by Ken Honeck and a second by Nic Riesenberg, the board voted to approve the financial report as presented 7-0.

Executive Director's Report

Ms. Macken shared that QuickBooks lost access to a few accounts and a deposit including funds from two CDs was not recorded properly. These issues are now resolved.

Next, Ms. Macken shared that following strategic planning, focus group participants have been contacted and a schedule has been developed. Additionally, all survey questions have been finalized and all agency staff are invited to participate in the survey. She also shared that several agency audits have been completed, with a final report to be provided to the board by January 15, 2024.

Finally, Ms. Macken shared an update regarding the school-based service grants, which included that many districts are struggling with a lack of play therapists.

Action Items

Next, adjustments to the CSF's 2023 budget were presented to the board for review. A total of \$10,000 originally budgeted for contingencies was not spent during 2023. Budget items needing adjustments were an additional \$7,000 for the audit and \$3,000 for salaries. With no adjustments needing to be made to the total budget due to the contingency, the 2023 budget totaled \$446,091.61. With a motion by Bruce Culley and a second from Ken Honeck, the 2023 budget adjustments were approved as presented.

The 2024 Healthcare Plan for CSF staff was presented to the board for review. Ken Honeck made a motion to approve the 2024 Healthcare Plan as presented. Kelly Kobylski seconded the motion and the board voted in favor 7-0.

Next, Ken Honeck presented the slate of officers for 2024 on behalf of Pastor Robert Franseen and the Nominating Committee. All current officers indicated they would like to continue to serve in 2024 and no other nominations were received. The current slate of officers for 2024 is outlined in the table below with a formal vote expected to take place in January. Those interested in serving as officers should contact Pastor Robert Franseen.

Beacon Mental Health Presentation

The board invited Elizabeth Stanford, Laura Bruce, and Brittany Semsch from Beacon Mental Health to present on the organization's programs. One of their successes includes the Youth with Vision program, which is a youth advisory council that talks with state legislators about the dangers of vape use. They also provide youth crisis and psychiatric services, including offering family support providers and an Enhanced Care Pathways (ECP) program, which provides wraparound services for emotional regulation. Finally, their school-based team has served over 1,000 youth in Clay County by providing individual, family, and expressive therapies for students. Following the presentation, Elizabeth Stanford, Laura Bruce, and Brittany Semsch answered questions from the members of the board.

Other Business

John McGovern reminded the board to complete their yearly executive director evaluations.

Next Meeting

The next Board of Directors meeting is to be held on January 17, 2024.
