## Call to Order

# Approve/Amend Agenda Items

The board reviewed the agenda for the February 21, 2024 meeting. Nic Riesenberg moved to approve the agenda. Pastor Robert Franseen seconded the motion and the board voted in favor 9-0.

#### **Visitor Introductions**

Ken Honeck welcomed in-person and virtual visitors to the meeting.

### **Approval of Minutes**

Pastor Robert Franseen made a motion to approve the minutes from the January 17, 2024 meeting. Bruce Culley seconded the motion and the board voted in favor 9-0.

#### **Finance Report**

Bruce Culley gave an overview of the financial report for January 2024. The total fund balance as of January 31, 2024 was \$12,377,793.57 with \$13,841,144.74 in total grants committed. Revenue in January 2024 totaled \$973,500.43 and expenses totaled \$1,471,171.15 for a total net operating revenue in January 2024 of (\$497,670.72). Sales tax revenue in January 2024 totaled \$954,550.89, a 3.98% decrease compared to January 2023. With a motion by Nic Riesenberg and a second by Rick Jones, the board voted to approve the financial report as presented 9-0.

#### **Executive Director's Report**

Ms. Macken shared that program service audits were completed and a committee meeting to review the audit report will be held soon.

Next, Kathy Macken shared that survey responses will be reviewed before the next strategic planning board meeting.

Additionally, she shared that the School-Based Services grant application opened on Feb 1, 2024 and an info session was held for school districts on February 6, 2024. She also shared that the Community-Based Services grant application will open on April 1, 2024. Copies of the grant application schedules will be sent to the Programs Committee.

Finally, Ms. Macken presented the following approved budget revision:

 Kearney School District reallocated \$20,000 to support their play therapy and human trafficking program.

#### **Action Items**

Next, Bruce Culley presented the 2023 Audit engagement letter from Marr and Company. With a motion by Bruce Culley and a second by Ken Honeck, the board voted to approve the audit as presented 9-0.

#### **MOCSA Presentation**

The board invited Melanie Austin and Josh King from MOCSA to present on the organization's programs. Highlights included being able to service six out of a projected 30 children so far with CSF support, and an outreach site within Clay County. Their services include providing evidence-based treatments such as trauma-focused cognitive behavioral therapy and University of Oklahoma Problematic Sexual Behavior Cognitive Behavioral Therapy. In addition, they also provide research-informed services such as play therapy, art therapy, and sand tray therapy. Following the presentation, Melanie Austin and Josh King answered questions from the members of the board.

# **Northland Therapeutic Riding Center Presentation**

The board next invited Shaney Othic, Kirsten French, and Cindy Sahl from Northland Therapeutic Riding Center to present on the organization's programs. Their therapeutic riding services have been able to assist special needs people ages 6 and up, with 31 children coming from Clay County. Services have been shown to help children with anxiety and depression and improve their communication and social skills. They also shared that CSF support has helped them recruit and retain volunteers, which are crucial to their success. Following the presentation, Shaney Othic, Kirsten French, and Cindy Sahl answered questions from the members of the board.

#### **Other Business**

Ken Honeck reminded the board that the second strategic planning board workshop will be held on March 11, 2024. Additionally, Ken Honeck reminded the board to complete conflict of interest forms and return them to Peggy.
