Call to Order

Ken Honeck called the meeting to order at 8:30 a.m.

Roll Call

John McGovern then called the roll. Deb Hermann and Kelly Kobylski were excused. All other members of the board were present.

Approve/Amend Agenda Items

The board reviewed the agenda for the August 21, 2024 meeting. Pastor Robert Franseen moved to approve the agenda. Nic Riesenberg seconded the motion and the board voted in favor 7-0.

Visitor Introductions

Ken Honeck welcomed in-person and virtual visitors to the meeting.

Approval of Minutes

Nic Riesenberg made a motion to approve the minutes from the July 17, 2024 meeting. Rick Jones seconded the motion and the board voted in favor 7-0.

Finance Report

Bruce Culley shared that the total fund balance as of May 31, 2024 was \$6,641,201.57 with \$5,340,276.67 in total grants committed. Revenue in May 2024 totaled \$975,200.74 and expenses totaled \$1,504,041.65 for a total net operating revenue (loss) in May 2024 of (528,840.91). Sales tax revenue in July 2024 totaled \$1,068,333.62, a 4.68% increase compared to July 2023. With a motion by Ken Honeck and a second by Rick Jones, the board voted to approve the financial report as presented 7-0.

Executive Director's Report

Ms. Seelbach presented the following approved budget revisions:

- Smithville School District reallocated \$52,853.40 from their remaining balance to support Counseling and Therapy.
- Northland Therapeutic Riding Center reallocated \$1,411.20 from their PATH conference to support Barn Assistants.
- Ability KC reallocated \$37,072 from Assistance Technology to support Therapeutic Preschool & Outpatient Therapies.

Next, Ms. Seelbach shared that a draft of the 2024 audit will be available at the next board meeting, and auditors will be present to answer questions.

Ms. Seelbach also shared that she has had application review meetings with Beacon Mental Health, Excelsior Spring Hospital, and Synergy.

Action Items

Ken reviewed financial considerations for 2024-2025 Community-Based Grant Awards. Pastor Robert Franseen then presented the Programs Committee's recommendations for 2024-2025 Community-Based Services grants, and recommendations for additional funding for the 2024-2026 School-Based Services . John McGovern moved to approve the committee's recommendations listed below, and Nic Riesenberg seconded the motion.

The board voted in favor 7-0 to award the following Community-Based Services and updated amounts for the School-Based Services:

Beacon Mental Health Presentation

The board invited Elizabeth Stanford, Laura Bruce, and Brittany Semsch from Beacon Mental Health to present on the impact of services currently supported by the CSF. Highlights included their successful Breathe Easier campaign, which educated on the harms of vaping and was piloted with North Kansas City middle schools. With continued CSF funding, Beacon Mental Health hopes to spread the campaign to other school districts. Following the presentation, Elizabeth Stanford, Laura Bruce, and Brittany Semsch answered questions from the members of the board.
